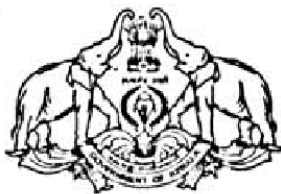

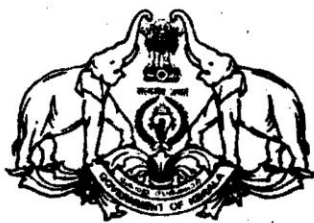
Explanatory Note

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have directed to include stipulated time limit for reporting vacancies under the different categories in the Excise Department to the Public Service Commission in the Kerala State Right to Service Act, 2012. Accordingly Excise Department have decided to notify stipulated time limit, the designated officers, the First Appellate Authority and the Second Appellate Authority for the purpose as per section 3 of the Kerala State Right to Service Act, 2012. Hence the amendment.

The notification is intended to achieve the above object.
